

**DOGGY DAYCARE

LIABILITY

1. I (the dog's owner) understand that if my dog has a history of aggression or biting, Fetch Brands LLC dba Fetch Academy reserves the right to refuse service and that all bites will be reported to the local authorities as required by law.
2. I (the dog's owner) understand that I am liable for any medical care expenses and damages that result from injuries caused by my dog.
3. I expressly waive and relinquish any and all claims against Fetch Brands LLC dba Fetch Academy, its subsidiaries, employees and representatives, except those arising from negligence on the part of Fetch Brands LLC dba Fetch Academy.
4. I have disclosed to Fetch Brands LLC dba Fetch Academy any and all known dangers associated with my dog including any illnesses.
5. I expressly understand and agree that Fetch Brands LLC dba Fetch Academy shall not be held responsible for any damage to my property, or that of others, caused by my dog during the period in which they are in its care.
6. I understand that under no circumstances will Fetch Brands LLC dba Fetch Academy be liable for consequential damages or damages beyond the replacement value of my dog.
7. If any medical problems develop while my dog is in the care of Fetch Brands LLC dba Fetch Academy, I authorize Fetch Brands LLC dba Fetch Academy to do whatever they deem necessary for the safety, health, and well being of my dog. Further, I agree to assume full financial responsibility for any and all expenses incurred.
8. I understand that Fetch Brands LLC dba Fetch Academy is a cage-free facility. I accept the risks involved and agree that Fetch Brands LLC dba Fetch Academy is not liable for any injuries or illnesses resulting during my dog's attendance.
9. I hereby declare to Fetch Brands LLC dba Fetch Academy that I am the legal owner of my dog; that my dog has not been exposed to Distemper, Rabies, or Parvo within the past (30) thirty days; that my dog has been inoculated as indicated by records presented; that my dog is currently and properly licensed; and that I (the dog's owner) have read this agreement in it's entirety.
10. I understand that Fetch Brands LLC dba Fetch Academy has the right to refuse service to me and to my dog at any time for any reason.

PAYMENT REQUIREMENTS

1. I understand that the hours of operation are 7am – 6pm and a \$10 late fee charge applies when the dog is not picked up by 2pm for a half day of service or by 6p for a full day of service. If I have not picked up my dog by the time employees leave the facility, my dog will be fed and boarded for the night at Fetch Brands LLC dba Fetch Academy. I understand I will be charged \$30 per night for boarding. Payment is expected before the dog is relinquished to the owner.
2. I understand drop off is from 7a-9a unless other arrangements have been made ahead of time.
3. Cancellations for daycare service must be received no later than 6p the day before; otherwise payment for the missed visit will be expected prior to your dog's next visit.
4. Home delivery services are available for \$20. Reservations are recommended.
5. A fee of \$29 will be charged for any returned checks.
